# **Recertification Quick Guide**

# 3 years = length of time an LPC credential remains valid

recertification = a way to extend your LPC credential another 3 years. This is repeated

# recertification methods =

- 1 LPC exam purchased and passed before your LPC credential ends on year 3
- 20 CEUs (Continuing Education Units) sent in before due date, each year of LPC credential (year 1, year 2, & year 3)
- 1 recertification application sent in before your LPC credential ends on year 3

#### recertification forms =

- 1 with exam recertification
  - <u>exam registration form</u>. We recommend starting the exam registration process 6 to 9 months before your year 3 due date ends
- 2 with CEUs recertification
  - <u>CEU accomplishment submittal form</u>. Fill and send in with activities totaling 20 CEUs before your year 1, year 2, and year 3 due date ends
  - <u>CEU recertification application form</u>. Fill and send in updating information, recommitting to our Code of Ethics, and reconciling cost(s) before your year 3 due date ends

#### notifications =

- 4 emails every quarter of every year showing your current CEUs and certification status
- 3 emails whenever a form is due
  - 1<sup>st</sup> email tells you what is due and when
  - o 2<sup>nd</sup> email tells you are late but within the grace period
  - o 3rd email tells you the consequences of missing the due date

**due date =** the last day of the month in which **you** passed your Original Exam. This month end date repeats through the years of your credential

grace period = 30 days. There is no penalty if you miss any due date, as long as you comply before the grace period ends

late = > due date + grace period

# recertification cost =

- by exam = \$300 each
- by CEUs = CEU processing cost + CEU late fees

## CEUs processing cost =

- \$0 for your life, for every recertification, providing you are a Lifetime Member, you send in 20 CEUs every year on time, + you send in your Recertification Application before every year 3 due date
- \$0 for 3 years, for a single recertification, providing you are a Member each of the 3 years, you send in 20 CEUs each of the 3 years on time, + you send in your Recertification Application before year 3 due date
- \$125 for 3 years, for a single recertification, providing you send in 20 CEUs each of the 3 years on time, + you send in your Recertification Application before year 3 due date

## CEUs late fees =

- \$30 if you are late sending in CEUs on year 1
- \$30 if you are late sending in CEUs on year 2
- \$90, plus loss of LPC credential, if you are late with anything due on year 3
  - late sending in year 3 CEUs
  - o late sending in recertification application on year 3
  - o late reconciling CEU processing cost on year 3 (30 days after invoice receipt)
  - late reconciling prior CEU late fees (30 days after invoice receipt)
  - o late reconciling a total of all 60 CEUs
